Instructions for Pre-Registration

- 1) Fill out one Pre-Registration Form for **each** person you are Pre-Registering. Improperly filled out forms will be rejected.
- 2) Do not alter form in any way. Alterations to form could invalidate Pre-Registration.
- 3) All Pre-Registrations for minors must be accompanied by their legal guardian's Pre-Registration. If you are registering a minor for whom you are not the parent or legal guardian, you must provide proper waivers. (See www.uprisingwar.org for details as mandated by the SCA inc.).
- 4) If you are Pre-Registering for multiple people at once, use the above form as an overview and tally sheet, listing the name from each form. In addition, please check appropriate boxes and total the charges. This is optional, a Separate Pre-Reg form is required for each person you are pre-registering.
- 5) Ensure that the Non-Member Surcharge is applied to all Pre-Registration forms filled out for non-members 16 or older.
- 6) **Proof of membership will be checked at Gate upon sign-in.** Please note that if proof of membership is not provided when you arrive on site, we MUST charge the Non-Member Surcharge, even if you are a member! Approved forms of Proof of membership include membership card, Kingdom Newsletter with membership number and date, Membership letter from SCA including web site printout. Please DO NOT send proof of membership with these forms.
- 7) Make payment by check or money order or other certified funds (Do NOT send cash!) in the amount determined above to "**The Barony of One Thousand Eyes, SCA, Inc.**"
- 8) Checks and money orders will be processed upon receipt. Checks will NOT be accepted after May 15th. There will be a \$20 charge for returned checks. No refunds after May 30th. Should you require a refund, please contact Reeve of 1000 Eyes or e-mail prereg@uprisingwar.org.
- 9) Enclose **payment** (check or money order), **Pre-Registration Form(s)**, and **Pre-Registration Totals Form** (if you chose to use it) in a big envelope, with correct postage, and mail to:

- 10) A confirmation e-mail and/or postcard will be sent to you as confirmation of your Pre-Registration. You should bring a copy of this confirmation and show it at Gate (Troll Point) upon arriving on-site.

Notes:

1. Failure to provide proof of membership will require us to charge the person listed above the Non-Member Surcharge. Proof of membership is defined as a photocopy of the blue (or white) SCA Membership card, a copy of your kingdom newsletter showing membership number and expiration date on the mailing label, or a confirmation postcard from the SCA, Inc., showing membership number and expiration date and vouching that your membership payment has been received.
2. As of January 1, 2003 the SCA, Inc. Board of Directors requires a non-member surcharge to be collected at all events. The Non-Member Surcharge (NMS) applies to each and every non-member old enough to be required to pay the adult rate site fee. The monies collected under this surcharge are passed directly to the Society and are not held or used by the Barony or the Kingdom. By this requirement, every person age 16 or over attending Uprising NOT having proof of membership¹ paying a standard site fee must be charged this NMS.
